Dear Tim:

On July 23, 2012, I sent you a letter requesting that you stipulate to the admissibility at the hearing on August 10, 2012, of the affidavits of Dershowitz, Tygart and Tomlonovic and to the authenticity and admissibility of the exhibits attached to those affidavits.

For the purposes of preparing a stipulation of uncontested facts, I also requested that you indicate by paragraph number any factual statements in USADA's three (3) affidavits which Plaintiff contests.

You responded on Friday, July 27, 2012, by suggesting that discussions on the above matters be put off until the week of August 6, 2012.

Tim, in my judgment there is nothing to be gained by putting off a discussion on USADA's requests until the week of the hearing. Delay will only make it more difficult and expensive for USADA to prepare for the hearing. Accordingly, I would respectfully request that you outline Plaintiff's position on the admissibility of USADA's three (3) affidavits and Plaintiff's position on the authenticity and admissibility of USADA's exhibits by the close of business on Tuesday, July 31, 2012.

As to providing an indication of which paragraphs in the affidavits Plaintiff dispute factually, I would request that you respond no later than this Thursday, August 2, 2012, in the interest of narrowing the issues for the hearing on August 10, 2012.
